Subject: One time cleaning of the database in the National Scholarship Portal (NSP), which is being monitored by DBT Mission Cabinet Secretariat

This is with reference to the D.O. letter No. 17-1/2020-SS dated 01.07.2020 issued by MHRD and this office Circular No. Scholarship/CBSE/NSP/2020 dated 04.02.2020 on the subject cited above. As per the direction given by the DBT Mission, Cabinet Secretariat, all schools/Institute have to register themselves on NSP.

The Ministry of Human Resource Development (MHRD) has desired to issue instructions to the schools affiliated to CBSE to re-register themselves on NSP so that eligible students from their schools, are able to avail scholarships under various schemes.

As informed vide above-said letter that for the year 2019-20, the email IDs and Mobile numbers of all schools registered in NSP have been de-activated by NIC. All the schools have to re-register themselves on the NSP to re-activate their account to enable the process of level-I verification at school level of applications for scholarship being received on the NSP from students of the respective schools. This is applicable to all scholarship schemes of various Ministries/Departments on-boarded on National Scholarship Portal (NSP).

However, it has been observed by the Department that out of 14.80 Lakh Schools/Institute across the country, only 5.1 Lakh Schools/Institute have verified on NSP as on 24.06.2020. As the National Scholarship Portal (NSP) is opened for the year 2020-21 in July, 2020, accordingly, the process of application/verification of scholarship already started from July, 2020. All schools including Private Schools should complete the process of re-registration to enable verification of scholarship application under the schemes concerned.

All the schools affiliated to CBSE, are, therefore, again requested to re-register themselves on National Scholarship Portal (NSP) so that eligible, meritorious needy students are not suffered due to non-registration of the school on NSP and are able to avail scholarships under various schemes as per their eligibility.


